This text is organized around the following major areas of managerial accounting: An Overview of Managerial Accounting. In this section, the text discusses the uses of managerial accounting and contrasts the type and use of information provided by managerial accounting and financial accounting (Chapter 1). Chapter 2 focuses on basic cost information and behavior. In this chapter we distinguish between the different types of costs incurred by organizations. The dedication of an entire chapter to overhead costs is considered necessary given the importance of controlling overhead costs to organizations in manufacturing inventory and providing services.
